What are the courses like?

You can find a brief module outline in our Short Courses Topics Outline pdf on our website. These self-paced courses offer:

- An intuitive and visually appealing interface to enhance the learning experience
- Content structured in "bite-sized" learning modules
- 15 20 minute session learning modules complete at your own pace
- Assessment has true/false or yes/no styled answers with some topics. If you choose to complete
 your questions, you will be issued with a Certificate of Participation which you may wish to use
 towards CPD points/hours that you are aiming to use for industry body requirements. Most of our
 Short Courses would equate to 3 CPD points/hours if utilising the MFAA guidelines but they must
 be relevant to your current or future profession.

Are there any prerequisites or equipment requirements?

There are no academic prerequisites for commencing the short courses. You just need to have a familiarity with using your computer and keyboard for typing answers into question fields.

How long will this course take to complete?

You have 3 months to access each short course that you choose so you can complete as quickly or as slowly as you prefer within this period. If you undertake the questions at the end of each unit, you could aim to complete in 2 to 4 hours.

How do I enrol and how much do they cost
