Important Notice To Applicants For Credit - relevant to Section 18(E)(1) of the Privacy Act 1988. All information provided by the applicant or company is subject to the Privacy Act 1988. Regarding disclosure of your credit information to a credit-reporting agency, NFI may give information about applicants/companies to a credit reporting agency eg. Equifax, for the following reason: Where NFI provides credit to the applicant/company in the form of this agreed instalment plan for course enrolment or course commencement or course completion by the applicant and payment is overdue by more than 30 days or following notice given to show that the intention is not to comply with payment obligations.

For all instalments payable on your nominated card above, you must ensure there are sufficient funds available to allow the instalment to be charged when it is due. You agree to notify us promptly if the nominated card is cancelled, suspended, due to expire or otherwise ceases to be a means by which we may collect payments. In this case, you must immediately nominate another card or pay the outstanding balance. Where your payment of an instalment is dishonoured, a default fee of \$10 becomes payable. We may reattempt to debit the instalment amount and the default fee from your nominated card at a later date. You will be liable to your card issuer or financial institution for any dishonour fees incurred on your nominated card.
