Course re-enrolment fee (see course re-enrolment form)	\$695 workshop; \$495 d/ed; \$395 online
RPL full fee (see RPL application form)	From \$695 to \$995 depending on qualification chosen
Payment plan setup fee	\$40
Payment plan instalment instance default fee	\$10
Workshop transfer (face to face or Zoom)	
A request made to transfer to another scheduled workshop with 7 or more days' notice of the commencement of the first scheduled day.	No fee
A request made to transfer to another scheduled workshop with 3 to 6 days' notice of the commencement of the first scheduled day.	\$45 administration fee
A request made to transfer to another scheduled workshop with less than 3 days' notice of the commencement of the first scheduled workshop day.	\$75 administration fee
When a trainee attends the first scheduled day of the workshop and then requests to transfer from that scheduled workshop to another - a fee will apply and approval will only be given in exceptional circumstances and at NFI's discretion.	\$100
A request made to transfer from a pre-booked Workshop back to online/distance learning study, after a workshop place has been reserved, where online access has already commenced. Difference in course fee may or may not be refunded. Transfer fee applicable.	\$100
A request made to transfer from a workshop enrolment to an RPL enrolment, within 7 days of the scheduled first date of the workshop, and where no course material has been issued or login attempts have occurred.	\$100
Transfer - online/correspondence/RPL	
If a trainee requests to transfer from one online/distance course to a different online/distance course, this will incur a transfer administration fee, which may be in addition to any difference in regular course fee.	\$50 per module or qualification
A request made to transfer from a course offered online / distance to a RPL application, where course login details have already been provided.	\$100
For courses undertaken on a unit by unit basis - any request for transfers to a different course or unit must be received within 5 working days of the original login being issued or a per unit transfer administration fee will apply.	\$49 per unit

<u>Refunds</u>	
Study course refund request application fee	10% of full course fee paid
A refund request received after 30 calendar days of student's commencement of course is determined on a case-by-case basis to a maximum of 50% of original full course fee paid. Refunds do not apply for change of mind nor for one unit at a time or single unit enrolments.	10% of full course fee paid (ie. refund application fee), plus 50% of course fee paid
A course refund request received after 6 months after student's commencement of course is not eligible ie. there is no refund consideration after 6 months.	n/a
Administration fee applicable for an RPL application which has been paid by an applicant, and which results in a non-approval result (applicant's course fee can be credited towards study of a qualification or may be refunded at management's discretion).	\$100

Issue of Interim Statement of Attainment (eg. unit by unit upon completion), per issue	\$29.95
Re-issue of single transcript by mail, no edits	\$29.95
Re issue of single certificate by mail, no edits	\$29.95
Re issue of single certificate or transcript by mail or email, with edits eg. change of name	\$29.95
<u>Extensions</u>	
Request for course extension, for an additional 3 months	\$99 per course
Request for short course extension ie. 1 month extension	\$50 per course
When a trainee is enrolled into a dual qualification (full enrolment) and applies for a 3 month extension	\$99
When a trainee enrolls in a single unit of competence and applies for a 1 month extension	\$50
When a trainee enrolls in a single unit of competence and applies for a 3 month extension	\$99
<u>Assessments</u>	
When a trainee requests longer than 21 days to resubmit an assessment or assessments, which were not passed on their first attempt. Fee is equivalent to a regular 1 month extension fee.	\$50
4 th attempt at an assessment incurs a re-assessment fee	\$99
